The property listing will also be available on the Collector's website after July 1 of each year. The Trustee's representative, William F. McCullah, will be available after the sale to have discussions with prospective purchasers.

Trustee instructions are updated annually, and available on the Stone County Collector's website, www.stonecountycollector.com. Please see the website for specific dates and annual requirements from the Trustee.

Attached is a list of properties within a Neighborhood Improvement District in Stone County. Sealed bids will be accepted on these properties until Tuesday, September 10, 2019. The Trustee will reject any bid less than the amount of accrued taxes, special Assessments, penalties, and interest. All bids must be at least the amount of accrued taxes, special assessments, penalties, and interest. To all bids, the Trustee will add \$177 for the Collector's advertising and notice expenses.
